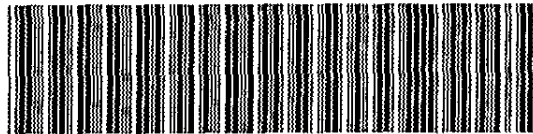

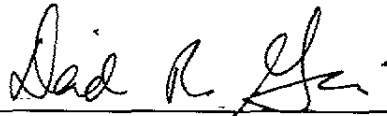
ARTICLE IV
