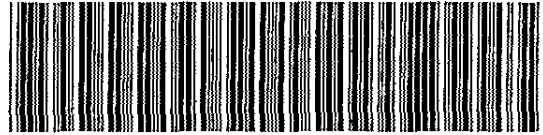

ARTICLE I
NAME

The name of this Limited Liability Company is W. P. Brett Associates, L.L.C.

ARTICLE II
EFFECTIVE DATE AND DURATION

EFFECTIVE DATE
01/01/04

The effective date of this limited liability company shall be January 1, 2004. This limited liability company shall have a perpetual existence unless sooner terminated as provided herein.

ARTICLE III
PURPOSE

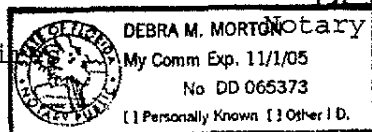

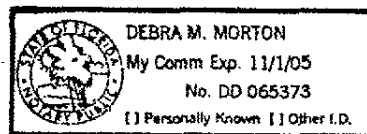
