**ARTICLES OF ORGANIZATION FOR
FLORIDA LIMITED LIABILITY COMPANY**

ARTICLE I - Name

The name of the limited liability company is GTA, LLC.

ARTICLE II - Address

The mailing address and the principal office of the limited liability company is:

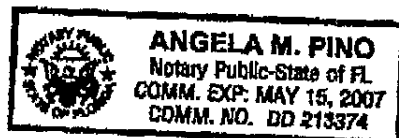
