**ARTICLES OF ORGANIZATION
OF
NATIONWIDE FUNDING SOLUTIONS, LLC**

For the purposes of forming a limited liability company under Ch.608 of the Florida Statutes, it is respectfully requested of the Secretary of State the approval of such organization under the following Articles.

ARTICLE I

The name of the limited liability company shall be **NATIONWIDE FUNDING SOLUTIONS, LLC** and its principal place of business shall be in South Florida with the right to move said principal place of business and establish other places of business within or without the State of Florida as the Board of Directors may from time to time deem proper.

ARTICLE II

The specific purpose of this limited liability company is to engage in any lawful business, not withstanding, any activity or business with any or all powers for any or all purposes determined convenient or necessary by the Board of Directors as permitted under the laws of the United States and the State of Florida as may be restricted under these Articles and its By-Laws.

ARTICLE III

The total authorized capital of this limited liability company shall be one million units with no par value. All of such units shall be issued fully paid and non assessable at and for such consideration, whether the same cash, services fixed rendered, or otherwise and upon such terms and conditions as may be fixed by the Board of Directors of this limited liability company.

ARTICLE IV

The amount of capital with which this limited liability company shall begin shall not be less than five thousand dollars (\$5,000).

ARTICLE V

The limited liability company shall have perpetual existence, unless earlier terminated by due and proper legal procedures.

If a quorum is present, the affirmative vote of fifty-one (51%) of the units represented at the meeting and entitled to vote on the subject matter shall be the act of the members.

ARTICLE XIII

MEMBERS MEETING REQUIRED

The action of the members of this limited liability company must be taken at a meeting of the members of this limited liability company, duly called as provided by law, except as provided for in Article XI.
