The name of this limited liability company is T, LLC, a Florida limited liability company.

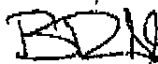
ARTICLE II. - ADDRESS

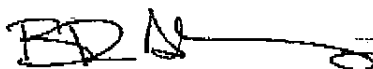
