### ARTICLES OF ORGANIZATION OF RIB SHACK OF NAVARRE, LLC

The undersigned hereby certify that we have associated ourselves together of ph 1:54 the purpose of becoming a Limited Liability Company under the laws of the State of ANY OF STATE Florida, providing for the formation, rights, privileges and immunities of limited liabilities companies for profit. We further declare that the following articles shall be the charter and authority of the conduct of business of such limited liability company.

#### ARTICLE I

#### NAME

The name of the limited liability company shall be RIB SHACK OF

and its principal place of business and for mailing shall be 7090 Calle Hernando De Soto, Navarre, Florida 32566, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

#### **ARTICLE II**

#### ARTICLE IV

#### **PROFITS AND LOSSES**

- (a) Sharing of Profits. The members shall be entitled to the net profits arising from the operation of the limited liability company business that remain after the payment of the expenses of conducting the business of the limited liability company. Each member shall be entitled to the distributed share of the profits specified in accordance with the percentage of membership interests that each member owns related to the total membership interests outstanding.
- (b) Losses. All losses that occur in the operation of the limited liability company business and the profits of the business, or, if such sources are insufficient to cover such losses, by the members in accordance with the percentage of membership interests that each member owns related to the total membership interests outstanding.


