ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF NEO GOV, LLC

Pursuant to the provisions of Section 608.411 of the Florida Statutes, NEO GOV, LLC, a Florida limited liability company (hereinafter, the "Limited Liability Company") adopts the following Articles of Amendment to its Articles of Organization:

FIRST:

The name of the Limited Liability Company is NEO GOV, LLC.

SECOND:

THIRD: The following amendment to the Articles of Organization was adopted by a duly authorized representative of a Member of the Limited Liability Company on February 3, 2004.
