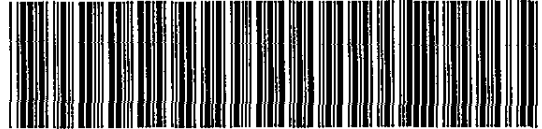


Management by Members

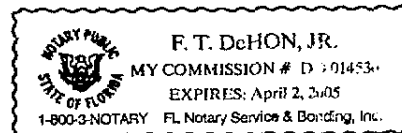


