ARTICLES OF ORGANIZATION OF TANGLED LINES OUTFITTERS, LLC

ARTICLE I - NAME

The name of this Limited Liability Company is TANGLED LINES OUTFITTERS, LLC.

ARTICLE II - ADDRESS AND PRINCIPAL PLACE OF BUSINESS

The mailing address of this Limited Liability Company is: P.O. Box 3096, Winter Haven, Florida 33885, and the principal place of business for this company shall be: 1154 Havendale Boulevard, Winter Haven, Florida.

ARTICLE III - DURATION

The period of duration for the Limited Liability Company shall be perpetual existence sooner dissolved according to law.
