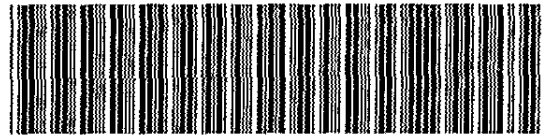

MANAGEMENT


This organization is to be managed by a Manager or Managers elected by a majority vote of
