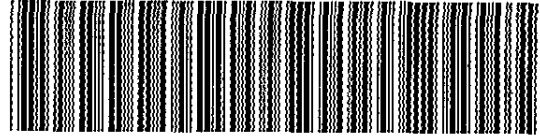

**ARTICLES OF ORGANIZATION

Amendments and addendums to these articles of organization shall be made by unanimous vote of the Members of the Limited Liability Company.
