

# ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF G & S GROUP, LLC.

Fursuant to the provisions of Section 608.411 Florida Statutes, this Company adopts the following Articles of Amendments to its Articles of Organization:

First: Article IV is hereby amended as follows:

#### Article IV MANAGEMENT
