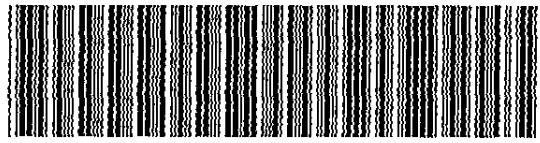



Articles of Organization for Florida Limited Liability Company

E -Z TIMES CHARTERS, LLC

Article I - Name and Purpose:

The name of this Limited Liability Company shall be E-Z Times Charters, LLC. The purpose of this Company is to provide guided charters, ecological/nature boat tours, and water taxi service for the Charlotte Harbor area and the Peace River.

Article II - Address:

Article IV - Contributions:

Member Captain Robert L. George has contributed a Crest 40 foot, 44-passenger pontoon boat and a Crest 22 foot, 6-passenger pontoon boat to the Company. Member Capt. George has contributed certain amounts of cash for the formation of the Company in amounts set forth in the Operating Agreement. Member Capt. George agrees to provide services of a professional marine boat captain to the Company.

Member Capt. Dennis J. Brew has contributed certain amounts of cash for the formation of the Company in the amounts set forth in the Operating Agreement. Member Capt. Brew agrees to provide the services of a professional marine boat captain to the Company.

Article V - Distributions and Proportionate Interest:

The Members understand and agree that the Company shall assume all payment obligations including, but not limited to, financial obligations, insurance, maintenance, repairs and up-keep, costs and expenses for the aforementioned boat contributions.

The Company shall make distributions to its Members according to the following formula: two-thirds to Member Capt. George and one-third to Member Capt. Brew until such time as the Members are fully reimbursed for the cash contributions made as set forth in the Operating Agreement. Thereafter, any distributions shall be made equally to the Members in accordance with the payment schedule set forth in the Operating Agreement.

Notwithstanding anything herein to the contrary, the proportionate interest in the Company and its profits and losses shall be allocated equally between the two Members, Capt. Robert L. George and Capt. Dennis J. Brew, their assignees, heirs, or estates.

Article VI - Effective Date:

The effective date of the formation of the Limited Liability Company shall be June 15th 2003.

Having been named as registered agent and to accept service of process for the above Limited Liability Company at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions with all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in chapter 608, F.S.
