The name of the limited liability company created hereby shall be: **Leaders of the future, LLC**



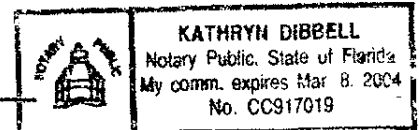

ARTICLE VI – Purpose and Powers

Leaders of the Future, LLC's Primary business activity will be providing instruction in arts/crafts and sports/recreation. Leaders of the Future, LLC's business activities may include, but shall not be limited to, the acquisition, disposition, leasing, management, and maintenance of real property and personal property. Leaders of the Future, LLC shall have the same powers as an individual to do all things necessary to carry out its business and affairs, including, but not limited to, all powers permitted by Florida Limited Liability Company Act, and the power to:

- A) Sue, be sued, and defend in its name.
- B) Purchase, receive, lease, or otherwise acquire, own, hold, improve, use, and otherwise deal with real or personal property or any legal or equitable interest in property, wherever located.
- C) Sell, Convey, mortgage, grant a security interest in, lease, exchange, and otherwise encumber or dispose of, all or any of its property.
- D) Purchase, receive, subscribe for, or otherwise acquire, own hold, vote, use, sell, mortgage, lend, grant a security interest in or otherwise dispose of and deal in and with, shares or other interests in or obligations of any other entity.
- E) Make contracts or guarantees or incur liabilities; borrow money; issue its notes, bonds, or other obligations, which may be convertible into or include the option to purchase other securities of Leaders of the Future, LLC; or make contracts of guaranty and surety ship which are necessary or convenient to the conduct, promotion, or attainment of the business of a corporation the majority of the outstanding stock of which is owned, directly or indirectly, by the contracting limited liability company; a corporation which owns, directly or indirectly, a majority of the outstanding membership interests of the contracting limited liability company; or a corporation the majority stock of which is owned, directly or indirectly, by a corporation which owns, directly or indirectly, the majority of the outstanding membership interests of the contracting limited liability company, which contracts of guaranty and suretyship shall be deemed to be necessary or convenient to the conduct, promotion or attainment of the business of the contracting limited liability company; or make other contracts of guaranty and suretyship which are necessary or convenient to the conduct, promotion or attainment of the business of the contracting limited liability company.
- F) Lend money, invest or reinvest its funds, and receive and hold real or personal property as security for repayment.
- G) Conduct its business, locate offices, and exercise the powers granted by Florida Statutes 608 within or without the state of Florida.
- H) Select managers and appoint offices, director, employees, and agents of Leaders of the Future, LLC, define their duties, fix their compensation, and lend them money and credit.
- I) Make donations for the public welfare for charitable, scientific, or educational purposes.

J) Pay pensions and establish pension plans, pensions trusts, profit-sharing plans, retirement plans, bonus plans, option plans, and benefit or incentive plans for any or all of its current or former managers, members, officers, agents, and employees.

K) Be a promoter, incorporator, shareholder, partner, member associate, or manager of any corporation, partnership, joint venture, trust, or other entity.

L) Make payments or donations or do any other act not inconsistent with law that furthers the business of Leaders of the Future, LLC.
