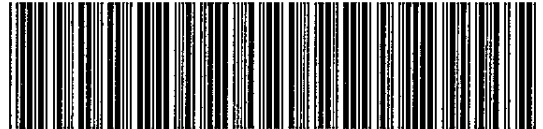

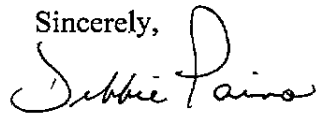

A. Article I of the Articles of Organization is hereby amended to read as follows:

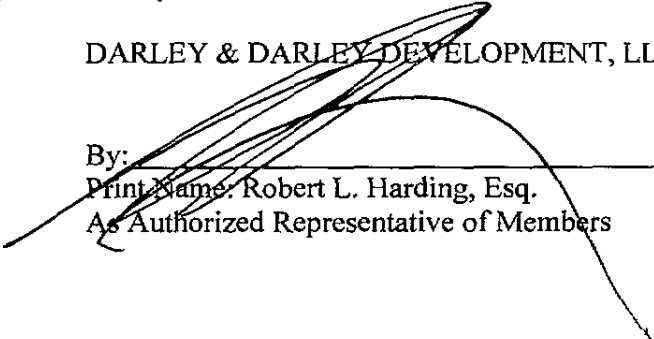
**ARTICLE I - Name**

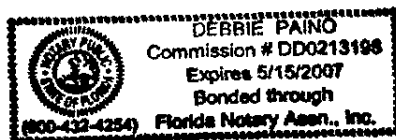

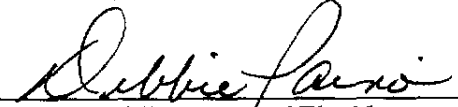
