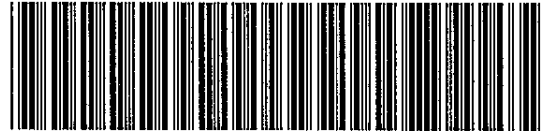

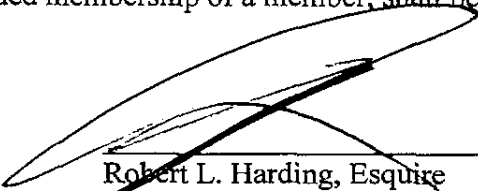
ARTICLE VI - Investment Qualification

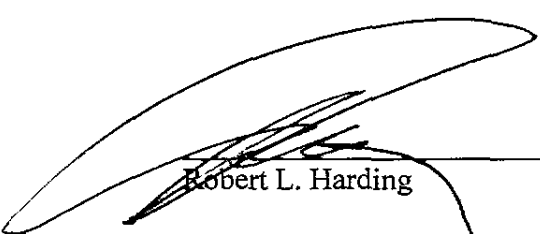
