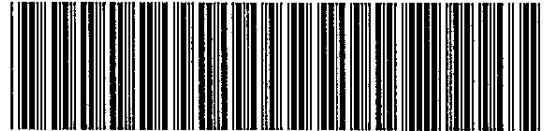

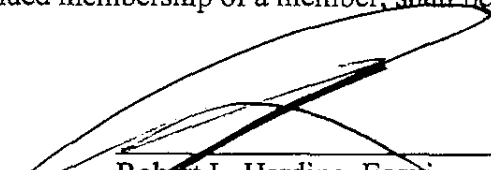

**ARTICLE VII - Miscellaneous**

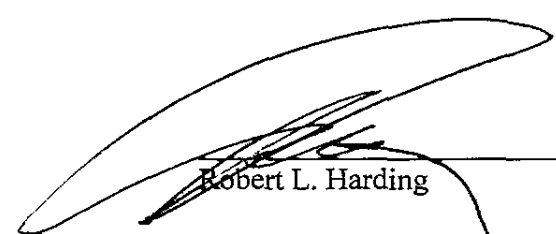
