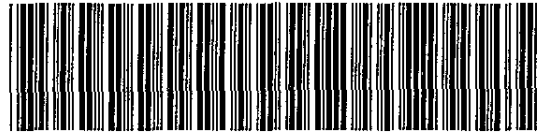

**FIRST:** The Articles of Organization were filed on June 19, 2003 and assigned document number L03000022372.


**SECOND:** The following amendment(s) to the Articles of Organization was/were adopted by the limited liability company:
