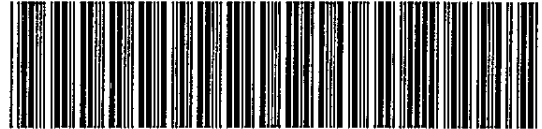



A portion of the South half (S 1/2) of the Southeast quarter (SE 1/4) of the Northwest quarter (NW 1/4) of Section 3, Township 36 South, Range 40 East, St. Lucie County, Florida, being more particularly described as follows:

COUNTY OF ST. LUCIE  
TALLAHASSEE, FLORIDA

Commence at the Southeast corner of the Northwest quarter (NW 1/4) of said Section 3, Township 36 South, Range 40 East, St. Lucie County, Florida, and run North 00°02'03" West along the East line of said Northwest one-quarter (NW 1/4), a distance of 69.62 feet; thence North 89°23'02" West 298.04 feet to the Point of Beginning; from said point of beginning continue North 89°23'02" West 81.96 feet; thence North 00°36'58" East, 180.00 feet; thence South 99°23'02" East, 81.96 feet; thence South 00°36'58" West, 180.00 feet to the Point of Beginning.
