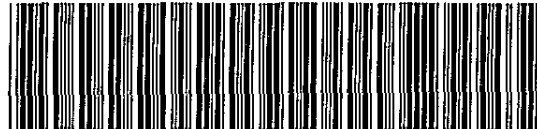

**ARTICLES OF ORGANIZATION OF  
GUARDIAN LANDSCAPE AND LAWN MAINTENANCE, L.L.C.**

**ARTICLE I. NAME**

The name of the Limited Liability Company ("Company") is GUARDIAN LANDSCAPE AND LAWN MAINTENANCE, L.L.C.

**ARTICLE II. PURPOSE**

The purpose of this Limited Liability Company may include the transaction of any and all lawful business for which Limited Liability Companies may be organized in the State of Florida.

**ARTICLE III. ADDRESS**
