# ARTICLES OF ORGANIZATION OF DTECH, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

### ARTICLE 1 - NAME

The name of the Limited Liability Company is DTECH, LLC (the "Company").

Transfer of membership rights shall be controlled by the Operating Agreement of the Company.
