**ARTICLES OF ORGANIZATION
FOR
H&R INVESTMENTS, LLC**

ARTICLE 1 – Name. The name of the limited liability company shall be H&R Investments, LLC.

ARTICLE 2 – Address of Principal Office. The mailing address and principal office of the limited liability company shall be 407 Center Pointe Circle, Suite 1637, Altamonte Springs, Florida 32701.


ARTICLE 3 – Registered Office and Registered Agent. The name and the Florida street address of the initial registered agent is Philip K. Calandrino, P.A., 29 East Pine Street, Orlando, Florida 32801.

ARTICLE 4 – Management. Initially, one manager shall manage the limited liability company. Therefore, it is a manager-managed company. The manager shall receive a salary for such services and may serve as manager until his or her resignation or removal for cause as determined by a majority vote of the members. The operating agreement for the company may modify the number of managers for the company and their respective terms.

ARTICLE 5 – Membership. The company may issue certificates to indicate ownership in the company; with one percentage of ownership interest equating to one membership unit, for a total of 100 membership units. No change of membership in the company may occur without the unanimous consent of all then-existing members and the manager.

ARTICLE 6 – Effective Date. The effective date of the limited liability company shall be June 13, 2003.
