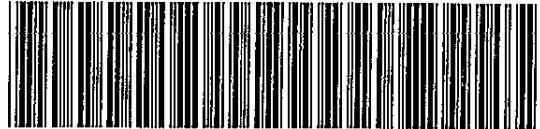

FOURTH: The Company is hereby dissolved pursuant to the unanimous consent of all members.

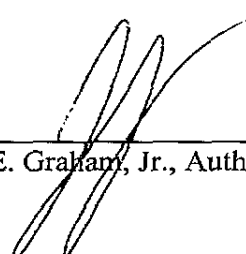
FIFTH: All debts, obligations, and liabilities of the LLC have been paid or discharged, or adequate provision has been made therefor pursuant to Section 608.4421.
