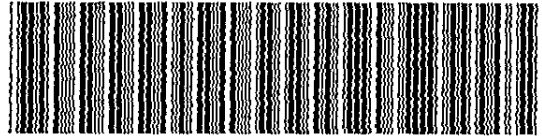



**ARTICLES OF ORGANIZATION
FOR

The undersigned, for the purpose of forming a limited liability company under the laws of the State of Florida, hereby adopts the following Articles of Organization:

**ARTICLE I
(Name)**

(Management)**




