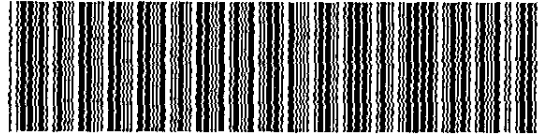

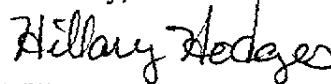

CONTINUING EXISTENCE

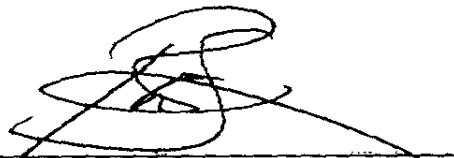
