

### ARTICLES OF ORGANIZATION

OF

## REEVES-JOSEPH & ASSOCIATES, LLC.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE 1 - NAME**

The name of the limited liability company shall be REEVES-JOSEPH & ASSOCIATES, LLC., ("Company").

#### ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 1470 San Marco Road, Marco Island, Florida 34145 and the mailing address shall be the smae.

#### ARTICLE 3 - EFFECTIVE DATE

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

#### **ARTICLE 4 - DURATION**

#### ARTICLE 5 - PURPOSES AND POWERS

#### **ARTICLE 9 - MANAGEMENT**
