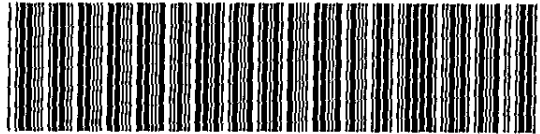

**Articles of Organization
for the
Law Office of Bruce Kuhse**

A Professional Limited Liability Company

The undersigned, being a licensed attorney in the State of Florida and desiring to form a professional limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, and the Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes, does hereby adopt the following Articles of Organization:

Article I: Name

The name of the professional limited liability company is Law Office of Bruce Kuhse, P.L.

Article II: Address

The street address of the principal office and the mailing address of the Company are:

Street address: 405 Holly Hill Court, Tallahassee, Florida 32312

Mailing address: 405 Holly Hill Court, Tallahassee, Florida 32312

Article III: Purpose

The Company is organized for the purpose of performing legal services and all other lawful business permitted under the laws of the United States and of the State of Florida.

Article IV: Duration and Existence Effective Date

The Company will exist perpetually, commencing on June 19, 2003, unless the filing of these Articles of Organization occurs more than five (5) business days thereafter, in which event such existence commences on the date of filing of these Articles of Organization with the Secretary of State of the State of Florida.

Article V: Continuation of Limited Liability Company

So long as the Company continues to have at least one remaining member, the death, retirement, resignation, expulsion, bankruptcy, or dissolution of any member, or the occurrence of any other event that terminates the continued membership of any member, shall not cause the Company to be dissolved, and upon the occurrence of any such event, the Company shall be continued without dissolution. At any time there are no members, the Company shall not be dissolved and shall not be required to be wound up if within one (1) year after the occurrence of the event that terminated the continued membership of the last remaining member, the personal representative or other legal representative of the last remaining member agrees in writing to continue the Company and agrees to the admission of the personal representative or other legal representative of such member or its nominee or designee to the Company as a member, effective as of the occurrence of the event that terminated the continued membership of the last remaining member.

Article VI: Registered Office and Agent

The Company hereby (i) designates 405 Holly Hill Court, Tallahassee, Florida 32312 as the street address of the Company's registered office, and (ii) names Bruce Kuhse, as the Company's registered agent at that address to accept service of process within the State of Florida.

Article VII: Management and Authority

The Company shall be a member-managed company. Subject to the limitations set forth in the Company's Operating Agreement, every member of the Company shall be an agent of the Company solely by virtue of being a member, and every member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member.
