Article III – Principal Office

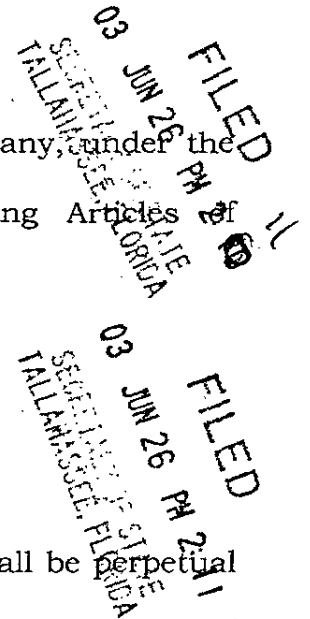

The management of the company is reserved to the members of the company, in proportion to their contributions of capital to the limited liability company. The power to adopt, alter, amend, or repeal the regulations of this






