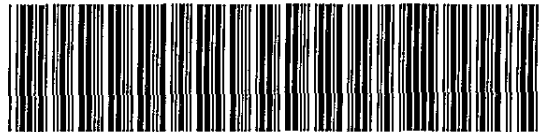

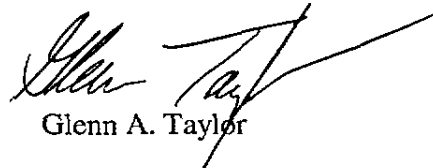

**ARTICLES OF ORGANIZATION
OF
EQUITY TITLE PARTNERS OF NORTHEAST FLORIDA, LLC
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, acting as organizer and as a Member or authorized representative of Equity Title Partners of Northeast Florida, LLC, under Section 608.407 of the Florida Limited Liability Company Act, hereby adopts the following Articles of Organization:

**ARTICLE I.
NAME**

The name of this limited liability company (the "Company") is Equity Title Partners of Northeast Florida, LLC.

**ARTICLE II.
ADDRESS**

The mailing and street address of the principal office of the Company shall be 12510 San Jose Boulevard, Jacksonville, Florida 32223.

**ARTICLE III.
INITIAL REGISTERED OFFICE AND AGENT**

The street address of the Company's registered office shall be 462 Kingsley Avenue, Suite 103, Orange Park, Florida 32073, and the registered agent for the Company at that address shall be Glenn Taylor.

**ARTICLE IV.
DURATION**

Except as provided in the Company's Operating Agreement (the "Operating Agreement"), the duration of the Company shall be perpetual.

**ARTICLE V.
PURPOSE AND POWERS**

This Company is organized with a general business purpose, specifically including, but not limited to the business of a title insurance agency, and has all powers provided by law and may use those powers to engage in any activities or business permitted under the laws of the United States, the State of Florida or otherwise.

**ARTICLE VII.
MANAGEMENT**

The Company shall be managed by one or more Managers (the "Managers") as further provided in the Operating Agreement.

**ARTICLE VIII.
ADMISSION OF NEW MEMBERS; TRANSFER OF INTERESTS**

The Company may admit new Members upon the approval of the Managers, *provided* the proposed Members assent to the terms of, and execute, the Operating Agreement. A Member may transfer his or her membership interest only in accordance with the terms and subject to the conditions contained in the Operating Agreement.

**ARTICLE IX.
DISSOLUTION**

Pursuant to Florida Statutes §608.441(c), the Company's business shall continue as provided in the Operating Agreement notwithstanding the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or upon the occurrence of any other event that terminates the continued membership of a Member in the Company.

**ARTICLE X.
LIMITATION ON AGENCY AUTHORITY OF MEMBERS**

Except as specifically authorized by the Managers, no Member of the Company is an agent of the Company or has the authority to make any contracts, enter into any transactions, or otherwise make any commitments on behalf of the Company.

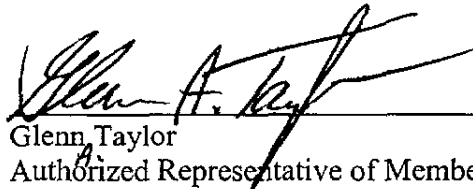
**ARTICLE XI.
AMENDMENT OF ARTICLES OF ORGANIZATION
AND OPERATING AGREEMENT**

Except as otherwise provided in the Operating Agreement, the Articles of Organization and the Operating Agreement may only be amended by a unanimous vote of the Members.

**ARTICLE XII.
RELATIONSHIP OF ARTICLES OF ORGANIZATION
TO OPERATING AGREEMENT**

If any provision of these Articles of Organization differs or otherwise conflicts with any provision of the Operating Agreement, then, to the extent allowed by applicable law, the Operating Agreement shall govern.
