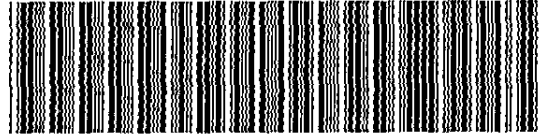

ARTICLES OF ORGANIZATION OF BBD, LLC
