**ARTICLE I

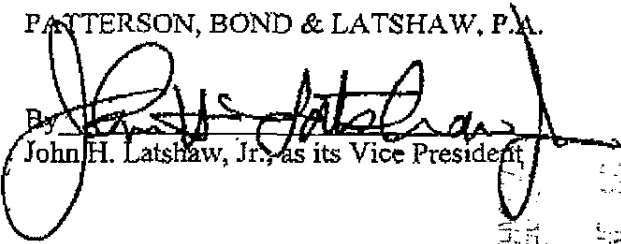
