ARTICLES OF ORGANIZATION

The undersigned, being a duly authorized member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is DR Clean, LLC, (the "Company").

ARTICLE V. REGISTERED AGENT AND OFFICE

Such Manager shall serve in such capacity until the first annual meeting of the Members or until his successors are duly elected and qualified.


ARTICLE VIII. REGULATIONS


