ARTICLES OF AMENDMENT

TO ARTICLES OF ORGANIZATION OF

JIMMY'S ICE CREAM, LLC

THE UNDERSIGNED hereby executes and swears to these Articles of Amendment to Articles of Organization of JIMMY'S ICE CREAM, LLC, a Florida limited liability company (the "Company"), pursuant to the Florida Limited Liability Company Act, as amended, Florida Statutes § 608.411:

- 1. Name of Company. The name of the Company is JIMMY'S ICE CREAM, LLC.
- 2. <u>Date of Filing of Articles of Organization</u>. The Company filed its Articles of Organization with the Florida Department of State on June 30, 2003, effective June 25, 2003 (the "Articles."
- 3. Amendment to Articles of Organization. Paragraph 1 of the Company's Articles is hereby amended by deleting the current text of Paragraph 1 in its entirety and substituting the following in lieu thereof:

"1. <u>Name</u>. The name of this limited liability company is **OLD MEETING HOUSE HOMEMADE ICE CREAM**, **LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida."
