ARTICLES OF ORGANIZATION

The undersigned, the sole member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is JAMDA-S.L., LLC (the "Company").

ARTICLE II. ADDRESS

The principle office and mailing address of the Company is:

ARTICLE III. DURATION AND CONTINUATION

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of State, and shall continue perpetually, unless terminated (i) in accordance with the Company's Regulations, (ii) by the unanimous written agreement of all Members, (iii) by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member, or (iv) upon the occurrence of any other event which terminates the continued membership of a Member. However, upon such termination event, the existence and business of the Company may be continued with the consent of a majority of the remaining Members of the Company, or by amendment of these Articles of Organization providing for the continued existence of the Company.

ARTICLE IV. PURPOSE

The Company is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. REGISTERED AGENT AND OFFICE

The Company designates 1725 University Drive, Suite 350, Coral Springs, Florida 33071 as the street address of the initial registered office of the Company and names George Levy the Company's initial registered agent at that address to accept service of process within this state.

Additional Members may be admitted upon the approval of a majority of the Members of the Company, upon the written application of such new Member, in the manner set forth in the Regulations of the Company.

ARTICLE VII. MANAGEMENT

The Company shall be conducted, carried on, and managed by the Members of the Company in the manner prescribed by and provided in the Regulations of the Company. The name and address of the initial Managing Member is as follows:

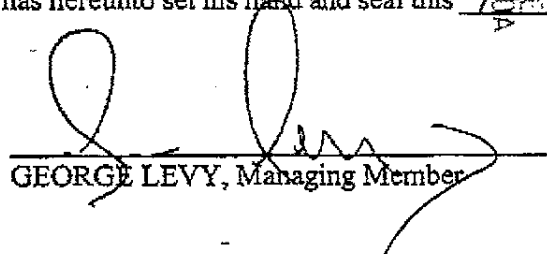
