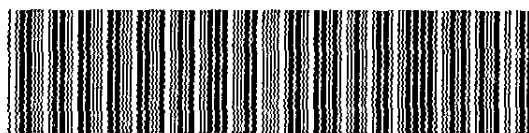



FIRST: The date of filing of the articles of organization was June 25, 2003.


