ARTICLES OF ORGANIZATION

OF

EUROGIB FINANCIAL, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **EUROGIB FINANCIAL**, **LLC**, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 12860 S. Cleveland Ave., Unit 233, Ft. Myers, Florida 33907-3822 and the mailing address shall be 117 Highland Rd., Portsmouth PO49DD, England.

ARTICLE 3 - EFFECTIVE DATE

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.
