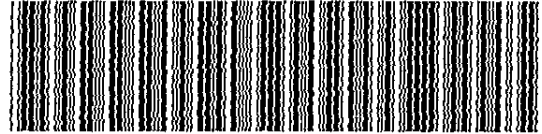




VIII.


