
V.



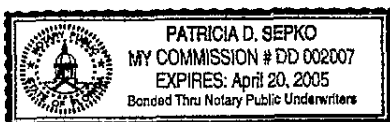
