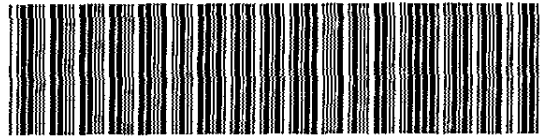

ARTICLES OF ORGANIZATION
OF
OCEAN INVESTMENTS OF WESTON, A LIMITED LIABILITY COMPANY

I, the undersigned natural person of the age of eighteen years or more, acting as organizer of a limited liability company under the Florida Limited Liability Company Act, adopt the following Articles of Organization for such limited liability company:

ARTICLE I

NAME

The name of the limited liability company shall be Ocean Investments of Weston, Limited Liability Company.

ARTICLE II

PRINCIPAL PLACE OF BUSINESS

ARTICLE IV

PURPOSES AND POWERS

1. **Purposes.** Except as restricted by these Articles of Organization and the Operating Agreement, the limited liability company is organized for any legal and lawful purpose for which a limited liability company may be organized pursuant to the Florida Limited Liability Company Act.
2. **General Powers.** Except as restricted by these Articles of Organization and the Operating Agreement, the limited liability company shall have and may exercise all powers and rights which a limited liability company may exercise pursuant to the Florida Limited Liability Company act.

ARTICLE V

REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered office of the limited liability company is 825 Stanton Drive Weston, Florida 33326 and the name of the initial registered agent at such address is Larry M. Aitkens. Either the registered office or the registered agent may be changed in the manner provided by law.

ARTICLE VI

MANAGEMENT

The limited liability company shall be managed by its managing member. No member in such capacity has the authority or power to act for or on behalf of the limited liability company, to do any act that would be binding on the limited liability company. The managing member is authorized to manage the business and affairs of the limited liability company.




