The name of this Limited Liability Company shall be GELUK L.L.C.


ARTICLE II: PURPOSE


ARTICLE X: AMENDMENT

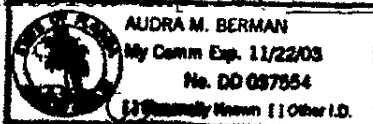


