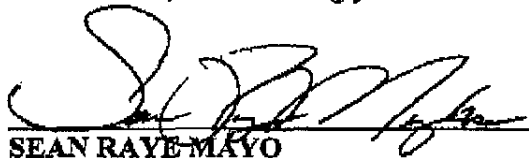
**ARTICLE V:

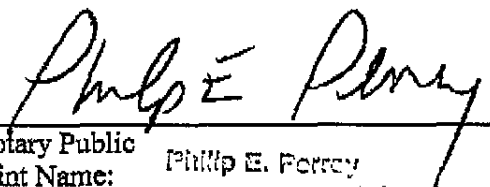
