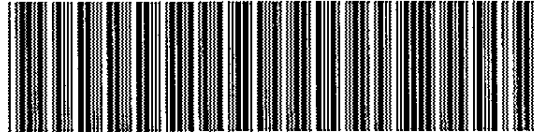

- (6) The Company has made adequate provisions for the satisfaction of any judgment, order or decree which may be entered against it in any pending suit.

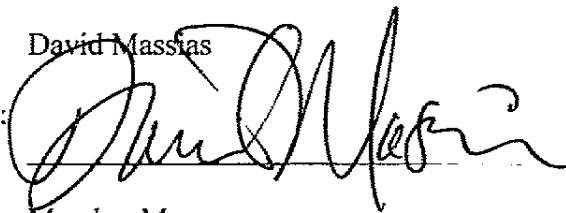
