**AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF
LAB GROUP, L.L.C.,
a Florida Limited Liability Company**

The undersigned, as an authorized representative of the members owning all of the membership interests of Lab Group, L.L.C. 
