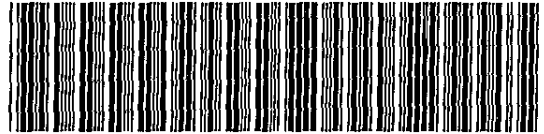

THE UNDERSIGNED, EDWARD J. DANEHY and KATHRYN MARIE DANEHY, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME AND PRINCIPAL OFFICE

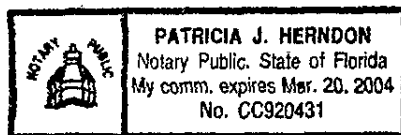
