Any Operating Agreement (as defined in Section 608.402(24) of the Act), relating to this Limited Liability Company must be in writing and signed by all of the members.


ARTICLE VII — Admission of New Members

ARTICLE VII -- Members' Right to Continue Business

The company shall terminate on December 31, 2099, or at such earlier date as provided in the Operating Agreement.


