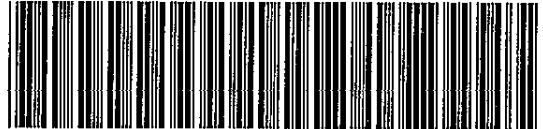


ARTICLE VI


