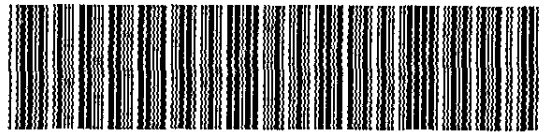

ARTICLES OF ORGANIZATION
OF

(1) To engage in all phases of furniture import and wholesale and such other business pertaining to the industry, and to engage in any other lawful purpose and/or business.

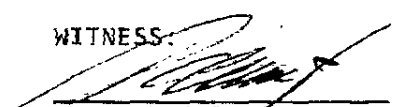

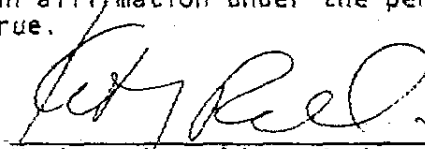
