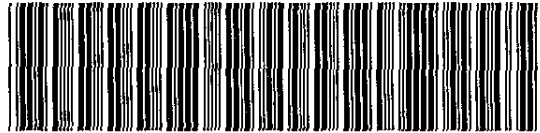

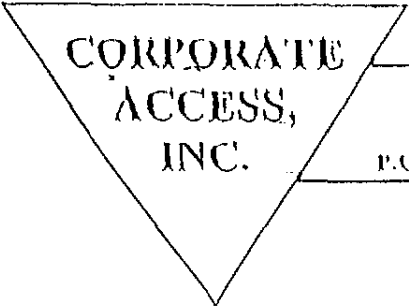

**ARTICLES OF DISSOLUTION
