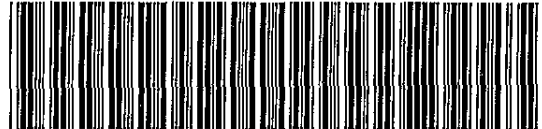

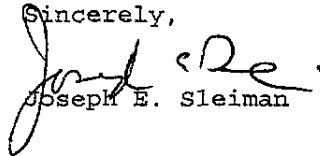

**ARTICLES OF ORGANIZATION  
OF  
SLEIMAN PICTURES LC**

The undersigned, for the purpose of forming a limited liability company under the laws of Florida, adopts the following Articles of Organization.

**ARTICLE I**

NAME

The name of the limited liability company is Sleiman Pictures LC.

**ARTICLE II**

ADDRESS

The principal office and mailing address of the limited liability company shall be c/o Joseph E. Sleiman, 2111 East Michigan Street, Suite 200, Orlando Fl 32806.

**ARTICLE III**

DURATION

The duration of the limited liability company shall be perpetual, and shall commence on the date these Articles are executed, except that if they are not filed by the Department of State of Florida within five days, exclusive of legal holidays, after the date they are executed, the company's existence shall commence upon filing by the Department of State.

**ARTICLE VI**

**MEMBERS' RIGHTS TO CONTINUE BUSINESS**

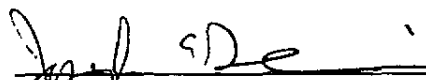
Upon the death, retirement, resignation, expulsion or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the limited liability company, the remaining member(s) of the limited liability company shall have the right to continue the business, provided each remaining member consents in writing.

**ARTICLE VII**

**INITIAL REGISTERED OFFICE AND AGENT**
