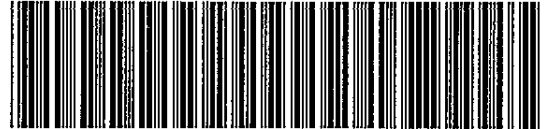

ARTICLE I


